

## Traci's Paws' Unleash the Holiday Cheer, Military Pet Adoption Sponsorship Fund Vouchers

All Military or Veteran individuals who request a "Military Pet Adoption Sponsorship Voucher" must adhere to all rules and regulations for a 100% donation, in the amount you paid to the rescue organization, shelter, or center the time of the pet adoption.

*Not all rescue organizations, shelters, or centers will want to approve a 100% sponsored adoption fee. All Military or Veteran individuals requesting a pet adoption with a Traci's Paws' Military Pet Adoption Sponsorship Fund Voucher must contact the rescue organization, shelter, or center in advance to ensure the organization will adopt, knowing the fee will be given back to the adopter, before proceeding with the adoption. You may provide the organization with a copy of this letter.*



Once the rescue organization, shelter, or center has agreed to accept the Military Pet Adoption Sponsorship Voucher, you will need to apply for the pet adoption with that organization. Once you have been approved and paid for the adoption fees, you will give the adoption coordinator handling your adoption the voucher to fill out. Once it is 100% complete, sign and return. **We may ask for a copy of your ID.** We will accept Military ID, Dependent ID, Veterans ID, DD-214 and Driver's License, NGB Form 22.

All Military or Veteran individuals who request a "Military Pet Adoption Sponsorship Voucher" must scan the completed & signed voucher with a copy of the adoption receipt in an email to Traci's Paws, Inc. at [SavePets@TracisPaws.com](mailto:SavePets@TracisPaws.com).

Once we have received this completed documentation, Traci's Paws, Inc. will send you a donation in the amount paid at the time of the adoption within 72 hours as long as funds are available.

Bill SB 245 allows veterans to adopt pets with only paying a small fee for microchipping etc... and some other organizations give military discounts. Even if it is not the full price of a "standard" pet adoption, we will still pay this fee to ensure all military and veterans are included. Just proceed like stated above, as if you were paying for standard pet adoption.

*All Military or Veteran individuals who request a "Military Pet Adoption Sponsorship Voucher" must allow Traci's Paws, Inc. to follow up with the adoption progress after one week and three months. The information you provide may be used as a success story for Traci's Paws, Inc. social media, website, and marketing materials and may also be shared with the organization from where you adopted your pet. Your information will not be sold or shared with any other organization(s).*

The "Military Pet Adoption Sponsorship Voucher" may be used for adopting a rescued pet only from a 501c3 rescue organization, shelter, or center for any type of pet. i.e., Small animals include rabbits, guinea pigs, hamsters, etc... birds, cats, and dogs. Pet store pets that have to be bought or pets that are the result of a breeding business will not qualify for a "Military Pet Adoption Sponsorship Voucher." If you purchase a pet, you will not receive a donation for the cost of the purchase.

**Traci's Paws' "Military Pet Adoption Sponsorship Voucher"**

This voucher is for all Military or Veteran individuals who are here to adopt a rescued pet. It is not to be used as the face value of the pet adoption fee at the time of the adoption. The adoption fee will be given back to the Military or Veteran individual in the form of a donation from Traci's Paws, Inc., AFTER they have been approved and paid for the adoption fees at your organization. As long as: funds are available, the individual has a valid Military/Government. ID adheres to the terms & regulations. This voucher must be completed in full, signed, and returned to Traci's Paws Inc. by the requesting Military or Veteran individual (voucher recipient) to receive a donation in the amount of the adoption fees paid today.
